- 2. Open forum: Paul Pawelek spoke with concern of raising the tax rate to \$1.6986. He feels this is extremely high. Runge and Karnes City are in the same shape and their tax rate is remaining the same. I hope there is an explanation for this, he stated. Don Moy spoke with concerns as to why the building cost started at \$23 million and is up to \$27-29 million. Also concerned with the detention pond and stated it needs to be "dealt with". Detention ponds should not hold water. There needs to be sod on the bare ground around the school. Roads need to be cleaned. There is water that stands in the parking lots. The contractor needs to tend to all of these items to ensure it is to the specifications. Jason Mabe stated he came to listen to public hearing but may have questions later.
- 3. Motion made by Jerry Jendrusch to approve bills and checks as written. The motion was seconded by Marlin Moczygemba. The motion passed unanimously.
- 4. Motion made by Mindy Jendrusch to approve 2015-2016 budget amendments as presented. The motion was seconded by Wayne Lyssy. The motion passed unanimously.
- Public Hearing on the 2016-2017 proposed budget and proposed tax rate was held. Superintendent, Todd Pawelek stated that we have our financial advisor, Dusty Traylor with RBC working on refinancing and restructuring of our bonds. The restructure, if approved, would lower the proposed I & S tax rate to about \$.52 per \$100 of valuation.
- Motion made by Marlin Moczygemba to approve the 2016-2017 budget with total revenues as \$8,799,251 and total expenditures as \$9,863,851 including maintenance and operations, food service and debt service funds. The motion was seconded by Wayne Lyssy. The motion passed unanimously.
