- 2. Citizens Open Forum No one spoke during open forum
- 3. Motion made by Jerry Jendrusch to approve consent agenda items. The motion was seconded by Kevin Labus. The motion passed unanimously.
- 4. Motion made by Keith Sekula to approve the 2016-2017 budget amendments as presented. The motion was seconded by Barbara Braune. The motion passed unanimously.
- 5. Motion made by Pat Jarzombek to approve to delegate contractual authority to obligate the school district under Texas Education Code 11.1511 (c) (4) to the Superintendent, solely for the purpose of obligating the district under TEC, Chapter 41, Subchapters A and D, and the rules adopted by the commissioner of education as authorized under TEC, 41.006. This includes approval of the Agreement for Purchase of Attendance Credits or the Agreement for the Purchase of Attendance Credits (Netting Chapter 42 Funding). The motion was seconded by Jerry Jendrusch. The motion passed unanimously.
- 6. A public hearing was held on the 2017- 2018 proposed budget and proposed tax rate.
- 7. Motion made by Jerry Jendrusch to approve the adoption of the 2017- 2018 budget as presented. The motion was seconded by Kevin Labus. The motion passed unanimously.
- 8. I, Keith Sekula move that the property tax rate be increased by the adoption of a tax rate of \$1.54, which is effectively a 16 cent increase in the tax rate. The maintenance and operations tax rate is \$1.06 and the interest and sinking tax rate is \$.48. The motion was seconded by Pat Jarzombek. The motion passed unanimously.

I, Barbara Braune move to order a tax ratification election to be held on October 14, 2017, and I further move to authorize the Falls City ISD Administration to take all steps necessary for the administration of the district's tax ratification election. The motion was seconded by Jerry Jendrusch. The motion passed unanimously.

 - Enrollment: First day enrollment is K-6-193, 7-12-160 for a total of 353

The goal posts that were bent during the hurricane have been fixed. We will have all three entrances open at all football games. Paragon Sports will have a food trailer at the Shiner game and will be selling bbq plates and will donate all the profit to the school.
