Communication Items:

- Budget Workshop on 2020-2021 Tax Rate and Budget
 Mr. Pawelek presented the budgeted revenue and expenses for the 2020-2021 school year.

 Revenue budgets were based on a proposed tax rate of \$1.46.
- 2020-2021 Remote and Face to Face Instructional Plan
 Mr. Pawelek presented various purchases made to support the remote and face to face
 instruction plans. Additionally, he discussed the steps to be taken to clean and sanitize the
 school. Water fountains have been disabled, so students are asked to bring a refillable or
 disposable water bottle.

So far, only 28 students have elected to participate in the remote instruction plan.

The remote learning plan is rigorous and that students at home will receive the same level of education as their peers on campus. The remote learning plan is set up so that an entire oncampus class can switch to a remote setting overnight if the need arises. Face to face students who are ill or showing symptoms can switch to a remote setting as necessary.
